Based on the data presented for report period July 1, 2021 through September 30, 2021. Indicators 8A ,8B and 8C met the 100% compliance target requirement for this reporting date range. During this quarter, the program continued to work with families via on-line home visiting, emails or personal phone connections with families with meeting our timelines. Since July 2021, GEIS has started face-to-face home visits and meetings with some families, and continue to add more families to face-to-face home services as families are comfortable and in agreement with.
