1. Can you please elaborate on this amendment? Does this mean that GDOE is now allowing bids with products not made in the USA? If so, how will preference for US made products be acted on? Some entities we do business with, for example, have a 5% preference threshold (based on cost).

2. I was hoping to hear back from you about Amendment No. 3, specifically regarding the change from Made in USA requirement to it now being just preferred. Would you be in a position to elaborate on Amendment No. 3? We are unsure of the weight of the preference and how preference will be acted on, quantitatively speaking. Any clarification on this confusing matter would be appreciated, as it affects costs quite substantially.

GDOE will be **REMOVING** the following verbiage from page 4, section 2.3 PROJECT DESCRIPTION, which will no longer apply to this IFB.

"This bid is subject to § 200.322 Domestic preferences for procurements.

- (a) As appropriate and to the extent consistent with law, the non-Federal entity should, to the greatest extent practicable under a Federal award, provide a preference for the purchase, acquisition, or use of goods, products, or materials produced in the United States (including but not limited to iron, aluminum, steel, cement, and other manufactured products). The requirements of this section must be included in all subawards including all contracts and purchase orders for work or products under this award.

- (b) For purposes of this section:

- (1) "Produced in the United States" means, for iron and steel products, that all manufacturing processes, from the initial melting stage through the application of coatings, occurred in the United States.

(2) "Manufactured products" means items and construction materials composed in whole or in part of non-ferrous metals such as aluminum; plastics and polymer-based products such as polyvinyl chloride pipe; aggregates such as concrete; glass, including optical fiber; and lumber."


