GDOE will be responding to questions that were inadvertently missed.

ACT ASPIRE

1. Regarding the February 4, 2022 proposal due date, would the GDOE consider extending to February 15, 2022 to allow respondents sufficient time to print and ship proposals and to prepare the required bid bond?

GDOE RESPONSE: The deadline for submission will be extended to 10am February 11, 2022. However, we will need time to for shipping of materials to be here in time for our test date, which is scheduled to begin on March 28, 2022.

2. Does the Department have a specific format or template by which bidders should provide additional off-the-shelf product terms and conditions which are applicable to the Bidder's Proposed solution or exceptions to the Department's terms and conditions?

GDOE RESPONSE: The terms and conditions are based on Guam Law and requirements from the Guam Attorney General's Office and therefore, it is in the best interest of GDE not to alter or to make changes to the IFB.

3. Please confirm that the ACT Aspire summative assessments will be administered in the Spring of 2022 with the ACT Aspire assessments administered between April 4, 2022, and May 13, 2022.

GDOE RESPONSE: As stated on the Scope of Work, GDOE will only be administering summative assessments which begins on March 28, 2022.

4. Will there be any ACT Aspire summative assessment participants requiring paper accommodations that would need to be shipped?

GDOE RESPONSE: There will be no paper accommodations needed at this time.



Amended Scope of Work

- a. ACT Aspire summative assessment materials in the areas of English, Reading, and Math aligned to the Common Core State Standards and the College and Career Readiness Standards for students in grades 3-7 – approximately 12,600 (online administration).
- b. ACT Aspire summative assessment materials in the area of Science aligned to the Next Generation Science Standards and the College and Career Readiness Standards for students in grades 3-7 – approximately 12,600 (online administration).
- c. Pre-ACT 8/9 summative assessment materials in the areas of English, Reading, and Math aligned to the Common Core State Standards and the College and Career Readiness Standards for students in grades 8-9 – approximately 5,300 (paper-based test materials).
- d. Pre-ACT 8/9 summative assessment materials in the area of Science aligned to the Next Generation Science Standards and the College and Career Readiness Standards for students in grades 8-9 – approximately 5,300 (paper-based test materials)
- e. Pre-ACT summative assessment materials in the areas of English, Reading, and Math aligned to the Common Core State Standards and the College and Career Readiness Standards for students in grade 10 – approximately 2,500 (paper-based test materials).
- f. Pre-ACT summative assessment materials in the area of Science aligned to the Next Generation Science Standards and the College and Career Readiness Standards for students in grade 10 – approximately 2,500 (paper-based test materials)
