

Dear Ms. Charfauros & Mr. Dela Cruz:

Reference GDOE PO 20210476-00 (attached) for 383x units of ERGOTRON YES20 Storage Cabinets received on 01/28/2021, PDS has been unable to confirm this item's availability for delivery from the manufacturer. We recommend that this item be substituted with another product, AC-VERT-24 Wall Mountable Charging Cabinet manufactured by ANYWHERECART, that is an equivalent product in features, available at the same price of the YES20 Cabinet, and can be supplied within the required delivery timeline.

We have prepared the attached comparison of the recommended replacement, AC-VERT-24 Wall Mountable Cabinet to the original Item C IFB requirements and the ERGOTRON YES20 that would be substituted. The comparison confirms that the proposed substitution meets or exceeds all of the original GDOE requirements and the features of the ERGOTRON YES20. We believe the product actually exceeds the requirements in key areas. A brochure for the AC-VERT-24 is also attached for your reference.

We respectfully request your approval to allow us to substitute the ANYWHERECART AC-VERT-24 for Item C of this procurement. This substitution would allow us to accept and fill the pending order that we have received for item C without impact on pricing or capabilities of the original Storage Cabinet. We also request that you approve use of the ANYWERECART AC-VERT-24 Wall Mountable Charging Cabinet for any future purchase orders that may be issued by GDOE for Item C of IFB 019-2020.
