The contractor shall remove and dispose of all light fixtures located on the underside of the existing walkway canopy sections shown in Drawing No. S-2A provided in this amendment. The contractor shall provide and install new light fixtures in the same locations as the removed fixtures with the following specifications and requirements:

Description: Premium vandal resistant outdoor luminaires for general illumination in rough service

- Housing: Ceiling surface mounted
- Construction: Large round 10.5" diameter die-cast aluminum premium vandal resistant bulkhead lighting, two-piece die-cast aluminum housing, black powder coated finish, smooth exterior injection molded and UV stabilizer white polycarbonate diffuser. Collar shall be provided for conduit installation.
