GDOE is hereby making the following changes to the IFB:

Section 6 – BID FORM

Replace **AMENDED Bid Form** from Amendment No. 3 in its entirety with **Attachment A – AMENDED Bid Form 2.**

GDOE has received the following questions and has deemed it in the best interest of the Department to respond to the questions and make necessary changes:

GTA

1. Please advise if a line item can be included for total NRC cost (column A x Column D) and if we can update the total price for evaluation to be based on Total monthly Price + Total NRC cost.

GDOE Response: Please see Attachment A – AMENDED Bid Form 2.

2. Also with the new updates in the Government, can you confirm if ZTE mifi devices will be acceptable. The federal Government in the NDA no longer accepts ZTE devices on Government networks.

GDOE Response: ZTE and Huawei devices, in particular, are banned devices. Devices from these companies cannot be used on the account of the current ban of Federal Agencies and contractors from using telecommunications equipment made by Chinese companies that policymakers see as untrusted - the Federal Communications Commission officially designated telecommunications companies Huawei and ZTE as threats to national security. Although not named, it is advised not to use any devices from Chinese companies due to this ban.

All else remains the same.
