Please see below responses to clarification request submitted by prospective bidder regarding Amendment No. 2 of the IFB:

**JMI Edison**

1. With reference to response on Question #7, Amendment No. 2 dated 2/18/2021, we still have additional clarification on the specification which mention "adjustable and fits up to 24" with or smaller. Our understanding that the front (24"H x 24"W and side (24"H x 18"W) panel size remain the same. The word smaller should not be include because it's fixed cut of the sizes? Do you have the size of the Student's desk for our reference?

***GDOE Response: Yes, the panel size remains the same. However, the sneeze guard must fit desks up to 24" including those smaller than 24". There are numerous styles and sizes of desks within GDOE. Therefore, shields that can accommodate all widths 24" or smaller is necessary.***
