**SET Electric Inc.**

For GWHS:

1. As shown on the SLD there are 4 Junction Boxes - where is the JB's located  
***GDOE Response: Intercept and install within the electrical room as shown on accessible location.***
2. After the JB's it goes to existing loads, are the conduits and cables going to existing loads included in the bid?  
***GDOE Response: No. Circuit(s) are to be intercepted as indicated. Conduits and cables to remain from new junction box to existing loads.***
3. Also, the cable and conduit sizes going to the JB's are not indicated.  
***GDOE Response: Cable and conduit sizes to match existing.***
4. Cable sizes for control circuit from Load Shed Panel to ATS is not indicated.  
***GDOE Response: Cables sizes for Load shed panel are per manufacturer's recommendation.***

All else remains the same.
