1. In review of the IFB 040-2021 SonicWall Firewall Upgrade, we found the following missing items in the BOM which would require an amendment to ensure the needed SKUs are purchased. Line-item No. 4 is for Sonic Wall Analytics IPFIX On Prem Unlimited Storage (Hardware) with 24/7 Support 5 Yr (service). The SKU listed, 02-SSC-1532, is only for the software and lacks the required and listed request of 5 years support. To get the required support, you would need to add quantity 5 of SKU 02-SSC-153 for 24X7 Support for Analytics On-Prem Unlimited Storage 1yr to the current BOM. Can you please advise if there will be an amendment to IF 040-2021?

GDOE Response: GDOE requires that the purchase come with 5 years maintenance and support. The bidder should provide and include the 5 years maintenance and support. It is the bidder's responsibility to ensure that the product provides the necessary 5 years maintenance and support.
