

\$8.5M in advance child tax credits processed, says DRT

If you're expecting an advance child tax credit payment, your check will soon be in the mail or deposited directly into your account.

The Guam Department of Revenue and Taxation processed 15,556 payments totaling \$8,499,895 on Monday.

"We're very excited to get those out. ... People can start to see their payments coming in either by mail or by direct deposit starting the end of this week," said DRT Director Dafne Mansapit-Shimizu.

This is the first of five installments for the advance child tax credit for Guam residents, according to a press release.

The other four installments of the advance child tax credit will be processed Sept. 30, Oct. 15, Nov. 15

and Dec. 15.

The American Rescue Plan Act of 2021 authorized the advance child tax credit. It gave mirror code territories the opportunity to elect to opt into the advance child tax credit for their respective jurisdictions. If the government of Guam did not opt in, island residents would have had to wait until they filed their 2021 Guam income tax returns in calendar year 2022 to benefit from the enhancements to the child tax credit.

The American Rescue Plan advance child tax credit provisions include:

- The maximum child tax credit increased to \$3,600 for children under the age of 6 and to \$3,000 per child for children between ages 6 and 17.
- The credit includes children who turn 17 in 2021.

- Taxpayers may receive part of their credit in calendar year 2021 before filing their 2021 Guam income tax return.

"Over the last year and a half, the Department of Revenue and Taxation has administered EIP1, EIP2, EIP3, Ayuda I Mangafa Help for Families, and most recently, the All RISE Program," said Gov. Lou Leon Guerrero. "The expanded child tax credit under the American Rescue Plan is now the sixth COVID-19-related program to be successfully executed by DRT, and we are thankful for the team working tirelessly behind the scenes to get this direct aid into the hands of our people."

Mansapit-Shimizu said many DRT employees "have been working six days a week for well over a year now."

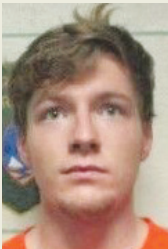

Moore indicted in criminal sexual conduct case involving underage victim

A Superior Court of Guam grand jury has handed down an indictment against Nicholas Wayne Moore on two counts of third-degree criminal sexual conduct. The indictment was issued Tuesday.

Moore stands accused of

having sexual relations with a minor who was under 16 around December 2016 and January 2017, according to the Guam Office of the Attorney General.

Moore is out on \$1 million bail in a separate murder case.

Moore, 23, and Troy Ryan Damian, 32, were indicted in July in a case that alleges Michael Castro was murdered.

Castro, 27, father to a little girl, disappeared in October 2020.

The prosecution has alleged

Castro was killed and his body was placed in a drum.

Castro's vehicle was found in a locked compound owned by an environmental cleanup business managed by Moore's father, according to court records.
