# SCHOOL CRIME STOPPERS PROGRAM

- Guam Public Law 31-100 created School Crime Stoppers to provide a safe school program in our public school system on September 30, 2011. This program aids law enforcement and school officials in reducing criminal activity and related problems in schools, on school grounds, and in the nearby communities. Situations involving the possession of illegal drugs and weapons, and destruction of property will be addressed. We work to make our schools a safer place for our children.

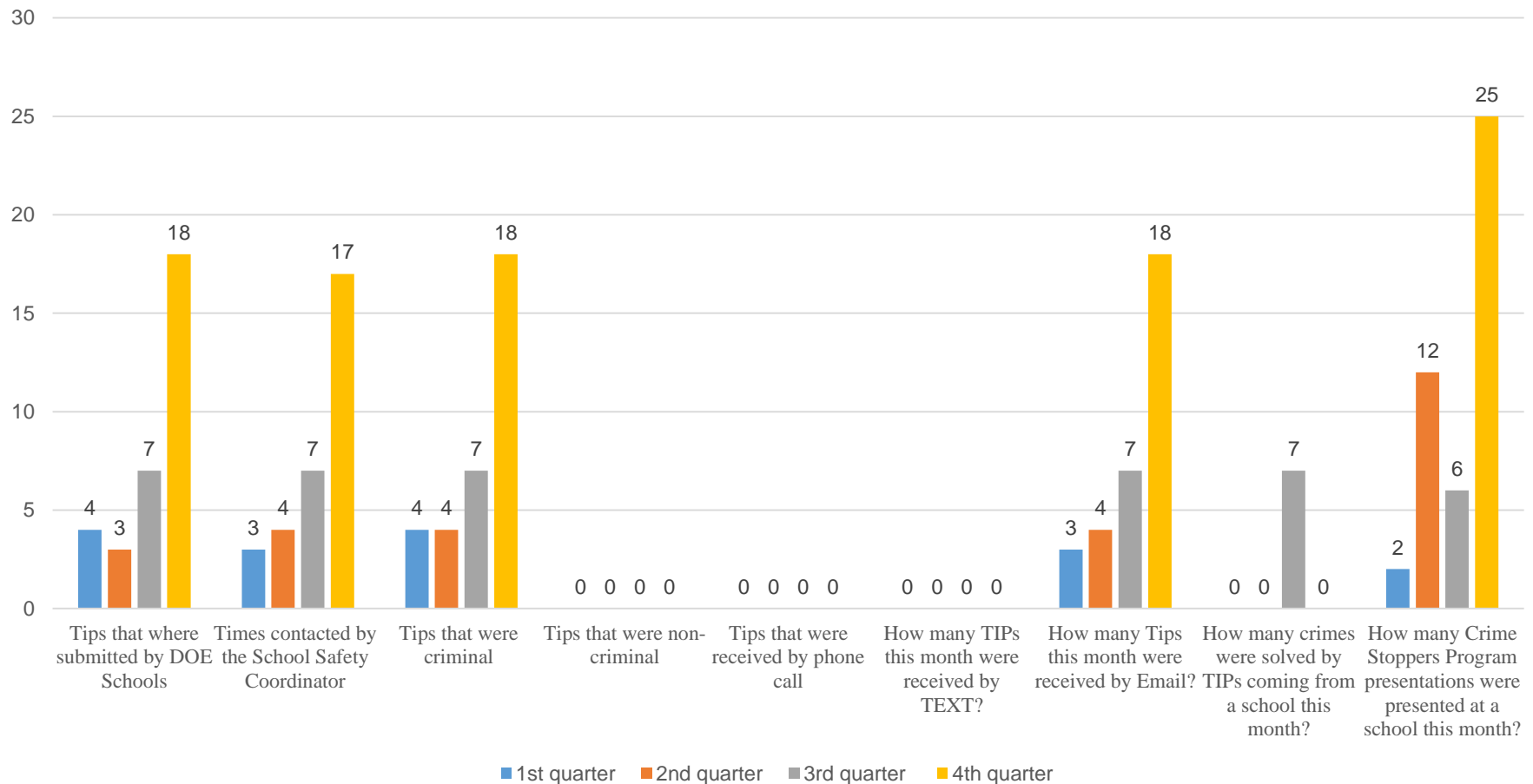


# **School Safety Coordinator (SSC) DUTIES AND RESPONSIBILITIES**

- Responsible for overseeing the DOE School Crime Stopper Program as a collateral duty.
- The SSC will coordinate with the School Crime Stoppers Coordinator-GPD (SCSC) to organize awareness and education events for students and the broader community.
- Check the “Tips Box” daily and notify the SCSC if there are tips for disposition and action.
- Collaborate with the SCSC in the collection and reporting of statistical data involving tips on a quarterly basis.
- The quarterly report format will itemize each tip, how it was received, and whether it was a crime or school rules violation. The report is submitted to the Student Support Services Division and published on the DOE website.

# **COMMON YOUTH CRIMES COMMITTED**

- Crime Stoppers will report any type of crime back to the school that is sanctioned in Title 9 G.C.A.
- Drugs: Inhalants; Synthetic Cannabis (Spice); Marijuana and Crystal Methamphetamines (Drug Ice)
- Assault
- Criminal Property Damage- Graffiti
- Thefts
- Robbery
- Burglary-School Break-ins
- Criminal Sexual Conduct



# HOW STUDENTS SUBMIT TIPS

There are three (3) ways for students to provide a tip while remaining anonymous.

1. Calling the hotline
2. Tip box
3. Online

# CALLING THE HOTLINE

Calling the hotline: 477 – HELP (4357)

- All calls and information will remain completely anonymous. Caller must provide a code name.
- The caller will state that they are a student and from what school they are from.
- They are given a timeline to call back and check on the tip.
- Should a tip generate an arrest or confinement at the Department of Youth Affairs and a tip payout is granted, *it is* the responsibility of the tipster to follow up with the case.

# TIP BOX

- Every school should have one
  - It is the responsibility of the School Safety Coordinator (SSC) to designate the placement of the tip box.
  - The designated SSC will check the tip box on a daily basis.
  - Should a tip be generated, the SSC will contact the SCSC and assess if the tip is criminal in nature or administrative concerns.
  - All criminal tips will be handled by the SCSC-GPD in disseminating information to respective Law Enforcement Agencies.
- \* The SSC and the SCSC-GPD will work together in resolving all cases.

# **TIP BOX CONTINUE**

- If disciplinary, the SSC will investigate and address with appropriate GDOE authorized guidelines.
- All investigation results from all tips will be documented and summarized on quarterly basis for GDOE, GPD and Guam Crime Stoppers statistical reporting.

Guam Crime Stoppers relies on cooperation among the police, media and the community at large to provide a flow of information about crimes and criminals. Crime Stoppers encourages residents of Guam to assist local law enforcement agencies in the fight against crime by overcoming the two key elements that inhibit community involvement: fear and apathy.

Crime Stoppers provides a telephone number and Web Tips to encourage citizens in the community to volunteer vital information helpful to law enforcement agencies to fight against crime.

### THE PHONE CALL

Calls are received at the Guam Crime Stoppers tips line phone at its call center. This phone is a stand-alone instrument that does not provide caller ID, and conversations are not recorded. The Guam Crime Stoppers call center completes the tip information form, and then passes the information to the proper law enforcement agency. By guaranteeing a caller's anonymity, Guam Crime Stoppers allows the caller to give information in a positive atmosphere without the prospect of retribution. By offering cash rewards for information leading to indictment or arrests, the program encourages otherwise reluctant callers to provide information. Callers can remain anonymous and are eligible to receive a cash reward if the information given leads to an arrest or grand jury indictment of a felony offender.

### THE WEB TIP

Tipsters have the option of providing on-line information simply by clicking the "Give a tip" button on any page. The process is completely secure and anonymous and is an effective and efficient means of safely communicating with Crime Stoppers. The unique integrated two-way dialog capability allows the tipster to come back and provide additional information to their tip at any time. It also provides a secure means for the call center to ask questions or provide reward information back to the tipster through the same secure and encrypted interface.

# **TIP PAY OUT**

- Tips for School Crime Stoppers are paid based on:
  1. School Sanctions (e.g. detention or suspension)
  2. An arrest or confinement at the Department of Youth Affairs
- The student will be paid based on a matrix and the crime up to \$200.00.

# REQUEST FOR GPD PRESENTATIONS

- To coordinate all training/presentations in all GDOE schools with the Guam Police Department, GDOE Student Support Services Division has developed a Google Request Form for schools to access via SSSD Links on our website.
- The Google Request Form will assist GPD with managing all school requests for presentations/training. The information requested is what GPD needs in order to process the request. If they need additional information, they will contact you directly. The data collected from the form will also let GPD and the Department understand that types of training that are in greatest demand. Upon electronic submission, GPD will provide a response to the request within five (5) business days. If you don't receive a response, please contact Student Support.



# **RECOMMENDED GRADE FOR GPD PRESENTATION**

- Elementary (3<sup>rd</sup> – 5<sup>th</sup>)
- Middle – (6<sup>th</sup> – 8<sup>th</sup>)
- High – (9<sup>th</sup> and 11<sup>th</sup>)

It is the responsibility of the SSC to coordinate dates and times for school presentations with the SCSC.

All presentations are highly encouraged to be held in a classroom setting. Please, NO CAFETERIA!

# **IMPORTANT NOTES FOR DESIGNATED SSC**

- All designated SSC will have to fill out and submit a “Confidentiality Clause” prepared by the Guam Crime Stoppers Board to ensure full anonymity is practiced.
- All designated SSC will ensure that all tip information remains confidential.
- Any information that is released will be punishable by law!!!
