Good morning, Delores,

Thank you for submitting a report of your State's proposed teacher shortage areas. The U.S. Department of Education (Department) has evaluated your proposed teacher shortage areas pursuant to specific provisions addressed in regulations concerning Federal student financial aid programs. The prescribed and alternative methodologies to calculate the proposed designated teacher shortage areas are addressed in 34 CFR Sec. 682.210(q)(6) and 682.210(q)(7), as well as assurances that must accompany the requested shortage areas.

In response to your submission, the Department has designated the following submitted academic disciplines or subject matter (noted at specific grade levels, if provided) and geographic regions (if reported) as teacher shortage areas during the 202X-202X academic year:

Mathematics

Science

Special Education

World Languages - Chamorro Language and Culture

For your information, the Department's approval of the proposed shortage areas in your State may benefit student grant and loan recipients who are qualified to teach in the academic disciplines, grade levels, and/or geographic regions in your State where the designated teacher shortages currently occur.

These benefits to student financial aid recipients, such as loan cancellations, are indicated in the following regulatory provisions:

- 34 CFR 682.210(b)(5)(ii), (b)(7), (q), and (s) enable a borrower who had no outstanding Federal Family Education Loan (FFEL) Program loan on July 1, 1987, but who had an outstanding FFEL Program loan on July 1, 1993, to qualify for deferment of loan repayment under the Stafford Loan Program anytime within the life of the borrower's loan(s) for up to three years of service as a full-time teacher in a private elementary or secondary school in a teacher shortage area designated by the Department, and as certified by the chief administrative officer of the particular school in which the borrower is teaching;

- 34 CFR 674.53(c) enables Federal Perkins Loan borrowers who are full-time teachers of mathematics, science, foreign languages, bilingual education, or any other field of expertise where the State

educational agency determined there is a shortage of qualified teachers to qualify for cancellation of up to 100% of the outstanding balance on the borrower's Federal Perkins loans; and

- 34 CFR 686.12(d) enables grant recipients to fulfill their teaching obligation under the Teacher Education Assistance for College and Higher Education (TEACH) Grant Program (regarding the requirement to serve at least four academic years, within eight years of graduation) by teaching in a "high-need field," which includes academic disciplines/subject areas identified as teacher shortage areas at the time the grant recipient begins teaching in that field.

Refer Federal Perkins Loan borrowers to the school where they received the loan.

*GDOE Response: Using data as of November 26, 2025, the Guam Department of Education employed approximately 1,783 total teachers for School Year 2025-2026. 89 positions designated as overall Teacher Shortages, out of which 34 positions are filled by teachers who are certified by irregular, temporary, emergency certificate or degree holders and 37 vacant positions, still pending to fill. See Figure 1 above.*

2. An assurance that the Chief State School Official (CSSO) consulted with private nonprofit elementary and secondary school officials within the state.

*GDOE Response: Through the efforts of the US DOE Consolidated Grant, State Fiscal Stabilization Fund (SFSF), and other programmatic grants, The Guam Department of Education maintains a collaborative relationship with private elementary and secondary schools within Guam.*

*GDOE Response: Individually, each proposed Teacher Shortage Areas accounts for less than 5% of the total FTE's as prescribed in 34 CFR. See Figure 1 above*
