

#### 1. What were the grantee's key accomplishments this past quarter?

#### **GDOE RESPONSE:**

- **♣** Education Stabilization Fund State Educational Agency (ESF SEA)
  - As of May 31, 2021, 94% or \$39.1 million of the total Guam Department of Education
     (GDOE) ESF SEA has either been obligated and/or in the requisition process.
  - Remaining funds will support personnel costs for employees performing duties directly supporting the ESF-SEA, proportioned costs for professional, software and installation fees for the automated \*Employee Time Tracking and the \*Fixed Assets Management systems, and professional fees for the \*Single Audit.
    - \* Proportioned cost with all grants/projects (Consolidated Grant, ESF-SEA, ESF II-SEA and American Rescue Plan Outlying Areas State Educational Agency (ARP-OA SEA)
  - GDOE is on target to fully expend the ESF-SEA grant funds on or before the end of the performance period.

#### **♣** Education Stabilization Fund II – State Educational Agency (ESF II – SEA)

- The GDOE Federal Programs Division (FPD) | Grants Office, serving as the State Educational Agency (SEA), submitted the revised ESF II SEA Project and Budget Narratives on June 4, 2021 after timely and meaningful technical assistance with participating Local Educational Agency (LEA) educational institutions.
  - o Revisions address Federal regulations and requirements as a result of the US Department of Education (US-Ed) recent guidance and as aligned to 34 CFR 299.9 (c)(2) and (e), whereas "no funds may be used for repairs, minor remodeling, or construction of private school facilities".
    - All prior requests, as applicable, for charter and private non-public school LEAs (non-publicly owned facilities) have been removed from the GDOE ESF II –SEA revised submission (June 4, 2021).
    - Affected educational institutions have opted to expand other previously submitted
      activities and/or requested for new activities as aligned with the ESF II SEA
      priorities, goals and objectives.
- Additional revisions included the proportioned cost with all grants/projects (Consolidated

Grant, ESF-SEA, ESF II-SEA and American Rescue Plan – Outlying Areas State Educational Agency (ARP-OA SEA) for the following activities:

- Automated Employee Time Tracking System | Institutions with Personnel related costs:
  The procurement and implementation of the Automated Employee Time Tracking will support project administration, allowing for the analyzation and improvement of Federal grant funded personnel productivity and accountability. Automation will help improve efficiency with monitoring of time spent by Federal grant project funded personnel.
- O Automated Fixed Assets Management System | Institutions with Equipment/Asset related costs: The procurement and implementation of the Automated Fixed Assets Management System will improve the administration and management of all Federal grant funded fixed assets. The system will help with the oversight, tracking, reporting and accuracy of real-time inventory to include acquisition, funding source, location, quality, condition, depreciation and survey of equipment information and support state monitoring activities.
- O Single Audit Professional Services | State Administration: In compliance with the Federal Single Audit Act, requirements that provides an objective examination of GDOE activities and hold it to account when spending Federal funds. Audit fees are based on overall grant award of each grant to be evaluated. Historically, overall audit costs have been shared between several Federal grants/programs including Head Start, Special Education, Discretionary, Child and Nutrition Program, Consolidated Grant and local funding. The ESF-SEA, ESF II SEA, ARP-OA SEA grants will be included in the Single Audit review requirements.
- As of May 31, 2021, 53% or \$58.7 million of the total GDOE ESF II -SEA has either been obligated and/or in the requisition process.
- Remaining funds will support the following:
  - O Personnel costs for employees performing duties directly supporting the ESF-SEA, professional, software and installation fees for the automated \*Employee Time Tracking and the \*Fixed Assets Management systems, and professional fees for the \*Single Audit.
    - \* Proportioned cost with all grants/projects (Consolidated Grant, ESF-SEA, ESF II-SEA and American Rescue Plan – Outlying Areas State Educational Agency (ARP-OA SEA)

- Procurement of professional development, additional educational tools and resources, additional Personal Protective Equipment including Plexiglas for teachers and students, and implementation of various extended learning summer and enrichment programs.
- O Procurement of professional services for contract management services, walkway canopies, HEPA filters, high energy efficient filtration/circulatory units, refrigeration and heating equipment for campus cafeterias, intercom systems and installations, thermal scanning equipment for multiple entryways for schools, and medical equipment for on-campus nurse offices, and student and teacher desks.
- Status of current activities implementation and ongoing Procurement, Delivery and Distribution of Equipment, Supplies and Contractual Services:
  - Technology Supplies and Equipment (i.e. laptops, tablets, peripherals) All current technology supply/equipment requests have either been completed or are in the final stages of the procurement process. Partial deliveries have been made on initial orders of technology supplies pending delivery of the remaining items.
  - Hard Copy Instructional Materials procurement have been ordered, partial delivery of items received. Ongoing procurement for the remaining Hard Copy Instructional Materials.
  - o Community Learning Centers:
    - An additional eight (8) GDOE public school campuses now serve as Community Learning Centers (CLCs) for a total of twenty-one (21) operating sites.
      - Services continue to be offered to all Guam students to utilize technology equipment, provide internet access and offer informative workshops to parents/guardians to better help students address educational gaps as a result of the COVID-19 pandemic situation.
  - o Personal Protective Equipment (PPE) and Health & Safety Materials:
    - PPE non-reusable supplies and materials (i.e. masks, gloves, sanitizing wipes, etc.) continue to be re-ordered as necessary for students, school site and ancillary personnel. Additional orders will support the Community Learning Centers, summer and enrichment programs, and the upcoming new school year as more schools prepare for the increased enrollment for in-person instruction.
    - PPE and Health & Safety equipment (i.e. handwashing stations, bottle filling

stations, thermal scanning cameras, etc.) initial orders have been distributed/installed at the various school sites. Additional orders to address the needs for thermal scanning at multiple school entryways is in the procurement workflow process.

- On-going monitoring of deliveries and installations at school sites such as hands-free water bottle filling and hand washing stations, and HEPA filtration units. On-going monitoring of activity implementation such as the Community Learning Centers and the recently implemented extended learning and enrichment summer programs, which commenced June 7, 2021 for grades Pre-K to 12.
- SY2021 Extended Learning Summer and Enrichment Programs:
  - O As a result of parents and student's high concerns relative to academic learning time loss, GDOE public schools have recorded a significant increase in student enrollment for the extended learning summer and enrichment programs, roughly a 300% increase. The elementary population accounts for a large representation of the total enrollment with 2,855, middle and high schools with 933 and 1,645 respectively. PPE supplies and materials are procured and distributed accordingly for summer schools sites.
  - Participating charter and private-non-public schools have or will implement Extended Learning Summer and Enrichment Programs in the coming days/weeks in an effort to address learning gaps.

# Federal Fiscal Year (FFY) 2021 American Rescue Plan – Outlying Areas State Educational Agency (ARP-OA SEA)

- GDOE FPD-SEA held the Virtual Stakeholders Consultative and Technical Assistance Workshop on April 23-30, 2021, providing timely and meaningful consultations with all educational institution representatives from the GDOE public, eligible participating private- non-public and charter schools. Sessions were held via a virtual pre-recorded platform from April 23 28, 2021, with a Live Question and Answer | Round Robin Session on April 29 30, 2021. All stakeholders were informed of the expectations and requirements of ARP-OA SEA. Workshop topics and discussions included the following:
  - o Overview of ARP-OA SEA | Grant Certification & Agreement
  - o Estimated Allocation per Educational Institution based on a per pupil cost
  - Allowable Uses of Funds
    - Grant Objectives and Conditions

- 20% Evidence-Based Interventions Requirement
- o Allowable, Reasonable and Allocable Requests
- o Infrastructure Expansion | Capital Improvement Requests
  - Timelines | Notice of Intent to Participate
  - ESF SEA and ESF II SEA Highlights
  - Maintenance of Effort Requirements
  - Monitoring and Accountability
- The GDOE FPD-SEA continues to provide guidance and technical assistance to supportall GDOE public, and eligible participating charter and private-non-public schools as they prepare for the return of in-person schooling in Fall 2021.
  - O As more students, faculty and school personnel are vaccinated, the confidence of returning to in-person continues to build. However, a moderate number of parents and students remain apprehensive about returning to campus. A considerable number of students and families have opted to continue with the online model of learning.
- With the ARP-OA-SEA Implementation Plan (due July 8, 2021), the GDOE FPD-SEA continues to work with participating public, charter and private, non-public educational institutions in the preparation of the ARP OA SEA Implementation Plan.
  - The finalization of the GDOE ARP-OA-SEA Implementation Plan awaits guidance relative to the applicability and process of Indirect Cost to the ARP-OA-SEA.
  - The GDOE FPD-SEA is on target to submit the GDOE ARP-OA-SEA Implementation Plan on or before the stated deadline of July 8, 2021.

#### 2. What were the grantee's key challenges this past quarter?

#### **GDOE RESPONSE:**

- The COVID-19 pandemic situation has presented a multitude of challenges on the education and island community affecting children and their families, as well as with the delivery of educational supports and project activity implementation/timelines:
  - Since the onset of COVID-19, Guam has experienced a large number of children impacted economically, academically, socially and emotionally.
    - O The increase in the number of transient, homeless and foster children is alarming. GDOE continues to assess the situation, as well as collaborate and provide support to schools, Guam Child Protective Services (foster children) and the Guam Department of Youth Affairs (GDYA) (incarcerated youth) in helping to support severely impacted

- at-risk students.
- Many high school students have suffered considerably, academically, emotionally and socially, with many enrolled in summer sessions to recover lost credits toward graduating on time or to graduate during the summer ceremonies.
- COVID-19 has also affected a large number of students, regardless of their economic status
  with many suffering with social and emotional stresses. For many, the economic stresses of
  their parents/guardians adds to their already fragile state.
  - o To help support students, the GDOE FPD-SEA proposes within the ARP-OA-SEA to provide and implement a summer youth employment program in collaboration with GDYA. The activity will serve multiple purposes and outcomes, providing 9<sup>th</sup> to 12<sup>th</sup> grade students, including recent 2021 graduates with opportunities to socialize with peers in a workplace setting, provide career exploration options, gain financial management skills, workplace experiences, life skills and a host of other experiences that will help prepare them for life.
- Guam has not reached its 80% COVID-19 vaccination target of its overall populations. As part of the return to in-person learning in the Fall of 2021, GDOE, in collaboration with the Guam Department of Public Health and Social Services, and the Governor of Guam's Office, have and continue to promote vaccinations to students, parents and personnel. Numerous outreach programs on school campuses were successfully implemented with more services being planned throughout the summer. The success of reaching its target will help to build confidence in returning to in-person instruction among cautious parents and students.
- As a result of the economic impact of COVID-19, the vendor pools have diminished causing a lack of, or minimal responses, to Request for Proposals (RFP) and Indefinite Quantity Bids (IQB). Although we have experienced a growing number of vendors that have reopened, the ability to meet the demands remain a consistent challenge considering the global supply and demand coupled with delivery to Guam, a remote location in the Western Pacific. Vendors have submitted numerous requests for extensions for deliveries and/or cancellation of orders due to lack of supply from manufacturers and/or shipping challenges. Additional challenges include the following:
  - o Additional time to an already lengthy procurement process;
  - Due to Guam's isolated geographic location in the Pacific Ocean, delivery of goods procured can take four (4) to six (6) months, in many situations, we have experienced extended delays with shipments; and
  - Nationwide shortages and competing demands for supplies and materials further delays delivery.

#### 3. What methods, tools, and processes are you utilizing to address these challenges?

#### **GDOE RESPONSE:**

- 4 Although delays and challenges are prevalent due to the COVID-19 pandemic, GDOE is making every effort to accelerate the implementation and expansion of activities. GDOE has and continues to carry out the following to ensure activities more forward and status continuously monitored and tracked collaboratively with the FPD-SEA and LEAs:
  - Collaboration between the Procurement Office, key LEA personnel, FPD-SEA and Management is on-going as it relates to accelerating the procurement of services, supplies, materials, and equipment for participating schools.
  - Collaboration with other GDOE divisions to streamline processes and increase efficiency in the implementation of approved activities.
  - Continuous communication with stakeholders, educational institution representatives from the GDOE public, eligible participating private-non-public and charter schools.
  - Communicating with vendors to ensure services, activities and deliveries are accomplished/received in a timely manner.
  - The GDOE FPD-SEA continues to develop and revise comprehensive Federal Grants Manual Guidance that will allow for consistent internal controls ensuring Federal compliance.

#### 4. How can the U.S. Department of Education help the grantee address these challenges?





## FFY 2021 ARP-OA SEA Virtual Stakeholder Technical Assistance and Consultative Workshop



The Guam Department of Education (GDOE) invites elementary, middle, and high school students to enroll for summer school SY 2020-2021. Registration is currently on-going and application forms are available for pick-up at your child's respective school. Application forms must be submitted to your child's school no later than Friday, May 7, 2021.

Elementary and middle school summer programs are designed to supplement instruction during the regular school year. These programs provide additional support to students who need or would like to spend additional time working on specific skills. Elementary and middle school summer school programs will run from June 7, 2021 through July 16, 2021.

The high school summer program is designed for credit recovery for students lacking 0.5 or more credits to graduate or be on track to graduate. The program will run from June 7, 2021 through July 22, 2021, and will be divided into four sessions. Students may earn a maximum of 2.0 credits (0.5 credit for each session).

- The face-to-face and online models of learning will be offered.
- Breakfast and lunch will be served.

## Parents, grandparents welcome start of summer school

After 18 months of parents helping to fill the role of teachers at home during the COVID-19 pandemic, the return of in-person learning has prompted some parents to express relief.

The Guam Department of Education's summer school program kicked off on Monday with more than 5,400 public school students maximizing their summer by making up for lost learning time in the classroom.

Several parents who spoke with The Guam Daily Post were excited to be dropping their children off at school.

"I'm totally excited for both them and me," said Suzanne Techaira, mother of two Guam Department of Education students. Her daughter, Zoiejean attends Untalan Middle School and her son Zianpeter goes to Ordot-Chalan Pago Elementary School. Cameron Concepcion, the mother of UMS seventh-grader Michael, said her son was also eager to go to school.

"He's actually excited to go to summer school. We are kind of relieved that the program opened up so that he could catch up from last school year. He needs to stay on top of his work," said Concepcion.

Even grandparents were excited.

#### Students 'really lost a lot'

"I feel good about it, I am glad that their education is continuing because they really lost a lot," said Salvador Avilla, who was picking up his two grandchildren from Untalan Middle School.

Techaira said, at first, she had several questions about whether her children would be OK with the "new normal" school environment.

"Today I did my checklist with them and they understand the importance of wearing a mask, washing their hands and keeping 6 feet apart," said Techaira.

Going through safety reminders gave Techaira reassurance that her kids were ready to venture back into the classroom, a decision she made after having her kids in the online learning model this past school year.

The online school this past school year was a huge task, she said. "I think I grew my first grey hair! My son Zianpeter even told me: 'You are my fake teacher, This is fake school," said Techaira.

She chose face-to-face so that her children could have a more structured education.

"Four days a week will help keep their brains motivated to learn and get off the electronics," said Techaira.

For the past school year, public school students have been for the most part learning from home. Students enrolled in face-to-face learning saw their teachers and classmates once a week. Those on hard copy had no face-to-face peer interaction, and students enrolled online spent their time in front of the computer screen.



#### From once a week to four

This summer school, students were able to enroll in either the online model of learning or face-to-face instruction.

The program geared toward recovering academic loss, students are now receiving instruction four days a week as opposed to once a week. Techaira hopes that being back in the classroom will make learning fun again.

"I normally have high expectations for school learning. But I hope my children see how much school is still fun since it was hard getting up and learning through a laptop this past school year. Actually, sitting for 40-50 minutes at a time is hard to do even for myself. By being in summer school they should be able to hold and retain knowledge ... and may just succeed even further than my expectations," said Techaira.

Kent Pueblo is also relieved that his daughter is getting more time in class. His daughter Kylie attends Wettengel Elementary School.

While Pueblo hopes summer school will help improve his daughter's writing and comprehension skills, he is just happy she will be developing her socio-emotional skills.

There aren't many kids her age within the family or neighborhood, Pueblo said, "so it's great to have her play with friends at school."

For Myra Soriano, socialization was the main reason for sending her seventhgrade grandson to school over the summer.

"It's been like more than a year that my grandson is just staying home. He was online, so this time I want him to be around other children to socialize," said Soriano.

GDOE officials have stressed the importance of socio-emotional development and have said the program would help transition students back to the classroom in preparation for next school year, when 85% of the public school population returns.

# Record enrollment: 1 in 5 students register for summer school

The Guam Department of Education this year expanded its summer school program to include all schools, with busing services and meals.

Nearly one in five students has registered for summer classes, said education Superintendent Jon Fernandez.

The summer classes are mostly face-to-face, Fernandez said, with some options for online instruction.

Summer school normally is limited to a few school campuses, but Guam DOE this year used federal pandemic funding to expand it to all schools, as part of an effort to help students make up for lost learning time during last year's lockdown.

All public school students were required to participate in distance learning at the beginning of the school year, and limited face-to-face instruction resumed in January.

Although summer school registration closed in early May, the schools aren't turning anyone away and will continue to accept students, Fernandez said. Parents should contact their child's school to enroll.

Classes are from June 7 through July 16 for most students, with high school classes ending July 22.

#### 19% enrolled

As of last week, 5,433 students were enrolled in summer school, which is about 19% of the total student population. Fernandez said it represents a 300% increase in enrollment, compared to past years.

It breaks down to: 2,855 elementary students; 933 middle school students; and 1,645 high school students.

kids back to a routine and in school."

He added: "I think a lot of the discussion of the learning impact COVID-19 has had is encouraging parents to enroll their kids."

Fernandez said only the high school courses are graded during the summer, with students earning as much as two credits toward graduation. Some of those students need the credits in order to graduate at the end of summer, during the "rainbow" graduation ceremony. There will be four three-week sessions, with each session worth half a credit.


#### **Extra instruction**

Elementary school and middle school students will not receive grades for their summer classes, he said.

"They're really coming for extra tutoring and extra time for instruction," he said. "They're not there to make up grades for the past year — they're really there because the need the extra time and attention and focus."

He said some students use summer school as a way to transition to from elementary school to their new middle school by taking summer classes at the middle school.

Guam DOE plans to work on the schools over the summer to get them ready for next school year, using federal pandemic money, but Fernandez said the work isn't expected to disrupt summer classes.

The Guam Department of Education registration process is ongoing for School Year 2021 – 2022. Parents and/or guardians should register students as soon as possible. Parents of students turning 5-years-old by July 31, 2021 are also reminded to register children for kindergarten.

Registration for School Year 2021 – 2022 will take place between Wednesday, March 17, 2021 and Tuesday, April 9, 2021.

#### **Registration Process**

To register your child at a Guam Department of Education school, please contact each school directly to ensure the proper registration forms are completed and submitted. Parents/guardians are asked to call ahead before picking up registration packets, and may also download registration packets at each school's website. Required registration documents include the following:

- Completed district registration forms
- Student's official birth certificate
- Parent/guardian current photo identification
- Court appointment guardianship document, if applicable
- Official transcript and official withdrawal from a previous school
- Proof of residency (ONLY one):
- Mayor's verification names of parents/legal guardians and children; or
- Copy of Mortgage Settlement/Deed to Property/Rental Lease
   Agreement/Base Commander's Certification clearly showing the complete

home address; or

- Utility Bill (power, water, or telephone); or
- Living arrangements if staying with a family/friend homeowner to provide a notarized letter
- IEP/EAP/ESL (most recent), or Agency Letter of Placement, if applicable
- Up-to-date immunization record
- TB requirements in accordance with Title 10 GCA 3329
- Physical examination (For Kindergarten, 6th grade, 9th grade, and all newstudents)

#### Safety Guidelines

Parents/guardians should call ahead prior to visiting each school in order to avoid crowding in school offices. All entering GDOE campuses are required to wear a mask, and visitors should report immediately to the main office where temperature screening will be conducted. Visitors may be asked to wait in their vehicles should doing so be necessary to enforce social distancing guidelines.

When submitting registration documents, parents/guardians should call ahead to schedule an appointment. Families may also contact schools directly to determine whether documents are being accepted via email.



#### Model of Learning Registration Form

Families will be asked to complete a Model of Learning Registration Form

upon registration. Due to COVID-19 safety concerns, the Guam Department of Education offers two models of learning. The form is being offered through the GDOE School Readiness Task Force, and aims to assess parental interest in enrolling students in one of the following options:

- Home Learning Online Instruction (Online Learning): This model of instruction and attendance is 100% online home learning. Students attend classes online and are required to have a computer or tablet, and reliable internet access. Additionally, though not necessarily required, access to a printer and scanner is beneficial.
- 2. Traditional (Face-to-Face): This model of instruction and attendance will be for students who will be participating in a blended model of face-to-face and distance (home) learning. Due to safety and physical distancing considerations, the District School Readiness Task Force has proposed using an alternating schedule, where 1/3 of students attend classes on any given school day. The proposed alternating schedule entails the following:
- Students are divided up into equally sized alphabetical cohorts.
- Cohorts will alternate days for physical attendance on campus.
- On days when students are not physically on campus, they will have assignments, projects or activities to complete and submit when they return. These assignments, projects, or activities can be provided and completed electronically or through hard copy depending on students' access to equipment and the internet.
- Alternating days will follow the same order and adjust accordingly for holidays.

Parents/guardians are reminded to return library books and other school items. To pick up any belongings left at the school, please contact each school directly.
